

KrisFlyer Enrolment Giveaway Contest Terms and Conditions (the “Terms”)

1. Individuals who are newly enrolled as KrisFlyer members and participate in the KrisFlyer Enrolment Giveaway Contest (“**Contest**”) in accordance with these Terms from 30 August 2026 (0000 hrs GMT+8) to 21 September 2026 (2359 hrs GMT+8), both dates inclusive (the “**Contest Period**”), will be eligible to compete for the prizes described in clause 7 below (the “**Prizes**”). By participating in this Contest, the participants are deemed to have accepted and agreed to be bound by these terms and conditions.
2. The KrisFlyer Enrolment Giveaway Contest (“**Contest**”) is organised by Singapore Airlines Limited (“**SIA**”) and is open to all eligible individuals who participate in the Contest in accordance with these Terms during the Contest Period.
3. To be eligible to participate in the Contest (“**Qualifying Entry**”), an individual must fulfil all the criteria set out below:
 - a. Register as a new KrisFlyer member during the Contest Period. Existing KrisFlyer members who enrolled before the Contest Period are not eligible. Please sign up [here](#) if you are not a member yet.
 - b. KrisFlyer members must be aged 18 years or above.
 - c. Select Hong Kong SAR China or Macao SAR China as the country/region of residence on the KrisFlyer registration form at the point of enrolment.
 - d. Submit the registration form (https://www.singaporeair.com/en_UK/hk/self-service/KFEnrolmentGiveawayContest) with the following details:
 - i. Full name (as shown on passport)
 - ii. KrisFlyer membership number
 - iii. Email address
 - iv. Answer the question of ‘**How would you spend 70,000 KrisFlyer miles?**’ in English or Traditional Chinese with less than 100 words including punctuations (each, a “**Submission**”).
 - e. Participants are responsible for ensuring their contact details and membership information are accurate and updated to receive relevant notifications.
4. Eligible individuals who participate in the Contest in accordance with clause 3 shall be referred to as “**Participants**”, and each a “**Participant**”.
5. Each Participant can only make one Submission. In the event of multiple Submissions, SIA reserves the right to disqualify all Submissions of that Participant. Entries made on behalf of another person will not be accepted and joint submissions are not allowed.
6. SIA reserves the right to verify the eligibility of Participants at its sole and absolute discretion.
7. On 5 October 2026, eleven (11) winners (each a “**Winner**”, and collectively the “**Winners**”) will be selected from the pool of Qualifying Entries. The Qualifying Entries will be judged based on their creativity, relevance to the question and unique merits, and the Winners shall be determined by SIA in its sole and absolute discretion. Each Winner will be entitled to one of the following prizes:

8. The list of the winners will be announced on 5 October 2026 on Singapore Airlines campaign page, which will include the Winners' surname, the first character of each Winner's first name, the first three and last three characters of their KrisFlyer membership number, and the Prize won by each Winner (e.g. Chan T** M**, 123****890, 70,000 KrisFlyer miles).
9. SIA will notify each Winner via the email address registered with the Winner's KrisFlyer membership profile by 6 October 2026 ("**Announcement Date**") with information on how to claim the Prize. If any Winner is determined by SIA to have breached any provisions in these Terms or the SIA Terms and Conditions and/or to be not eligible to participate in the Contest for any reason, that Winner's Prize will be forfeited and disposed of by SIA in its sole and absolute discretion.
10. The Winner is required to return a signed letter of acceptance in accordance with the instructions provided by SIA within ten (10) calendar days, together with all details that may reasonably be required by SIA for the issuance of the Prize to the Winner. If the signed letter of acceptance is not received by SIA by 16 October 2026, the Prize may be forfeited or another winner may be chosen by SIA, in its sole discretion.
11. Upon receipt of the Winner's signed acceptance, the Grand Prize will be credited to the Winner's KrisFlyer account within approximately six to eight (6–8) weeks. If crediting cannot be completed because the Winner's KrisFlyer account is not active or is not in good standing, the Prize may be forfeited.
12. Any miles awarded in accordance with this Contest will be valid for one (1) year from the date on which it is credited into the recipient's KrisFlyer account and no extensions to the validity period will be permitted. For the avoidance of doubt, the miles awarded which have not been used by the end of such validity period will expire and shall be deemed null and void.
13. Winners of the Aircraft model must collect their Prize at a venue designated by SIA. Collection details will be provided in the winner notification email. No delivery will be provided, and failure to collect the Prize in accordance with the instructions and within the stated period may result in forfeiture of the Prize at SIA's sole and absolute discretion.
14. The Prizes cannot be exchanged or redeemed for cash and shall not be transferred to another individual or KrisFlyer member. If any indication of abuse or violation of this provision is found, SIA reserves the right to cancel the Prize without any compensation.
15. Each Winner will be personally responsible for any and all additional costs incurred in connection with the acceptance and use of their Prize.
16. All KrisFlyer miles must be used in accordance with the terms and conditions of the KrisFlyer program found at https://www.singaporeair.com/en_UK/ppsclub_krisflyer/termsconditions-kf/. Transfer of KrisFlyer miles from one KrisFlyer member's account to another KrisFlyer member's account is not permitted.
17. Individuals are only permitted to hold one KrisFlyer membership account. Any fraudulent or duplicate KrisFlyer accounts, including the original KrisFlyer account held by such individuals will be suspended and disqualified from the Contest.
18. By taking part in this Contest, each Participant acknowledges and agrees that:

- a. each Participant may not submit, upload or publish any content that is inaccurate, misleading, libellous, defamatory, threatening, pornographic, obscene, indecent, lewd, abusive, illegal, political, racist, religious, blasphemous, false, an infringement of any intellectual property rights of a third party, or would otherwise violate or encourage the violation of any law or the proprietary or other rights of any third party (individually and collectively "**Improper Content**");
 - b. each Participant automatically grants SIA a worldwide, perpetual, irrevocable, transferable and royalty-free licence to use (including without limitation, to store, reproduce, modify, distribute, publish, display, communicate, transmit, podcast, webcast, or broadcast) and to sub-licence any and all intellectual property rights, title and interests (including copyright) in the Submission, including to repurpose and/or report their answers in other social media posts as and when it deems fit, without informing the Participant in advance; and
 - c. each Participant represents and warrants that:
 - i. all such Submissions are the Participant's own original works and creations and do not and will not infringe the copyright or any other intellectual property or other rights of any third party;
 - ii. none of the Submissions are proprietary or confidential;
 - iii. none of the Submissions are Improper Content, nor will they expose SIA to any civil or criminal proceedings in any part of the world; and
 - iv. the use by SIA and other users of the Submissions for the purposes and in the manner set out in these Terms will not require any further licences or rights from, or infringe any intellectual property or other rights of, any third party.
19. SIA reserves the right at any time in its absolute discretion to (a) cancel or modify the Contest; or (b) substitute, withdraw or cancel any Prize, without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever. All decisions by SIA, in respect of all matters relating to the Contest, including the choice of Winners shall be final.
20. By participating in the Contest, each Participant:
- i. agrees that any and all personal data he/she submits (including his/her name, KrisFlyer membership number, contact number and email address) may be collected, used, disclosed or otherwise (collectively, "**Processed**") by SIA for the purposes of facilitating the Contest, including to communicate with the winners on the Prizes. All collection, use, disclosure and processing of the Participants' personal data by SIA shall be in accordance with SIA's Privacy Policy (available online at https://www.singaporeair.com/en_UK/privacy-policy).
 - ii. agrees to comply with and be bound by these Terms, SIA's conditions of use of its website, SIA's Privacy Policy and the KrisFlyer Terms and Conditions (available online at https://www.singaporeair.com/en_UK/ppclub_krisflyer/termsconditions-kf). Non-compliance with or breach of any of these SIA Terms and Conditions may result in the Participant being disqualified at any stage of the Contest, and any prizes won may be forfeited, withheld, withdrawn or reclaimed, at SIA's sole and absolute discretion.

21. Employees of SIA, their immediate families, affiliates, subsidiaries, and related agencies, principal sponsors and suppliers associated with this campaign are not eligible to participate in the Contest. Corporations and other artificial persons are not eligible to participate in the Contest.
22. To the extent permitted under applicable law, SIA will not be responsible or liable for any consequences that any Participant may suffer (including without limitation any damage, loss, injury or disappointment) by entering the Contest or the Winner's acceptance of any Prize.
23. Unless otherwise specified, SIA is not responsible for and will not bear any of the expenses and all ancillary costs which may be incurred in the participation in the Contest and/or the Prize.

25. In the event of any inconsistency between these Terms and any advertising, promotional, publicity, or other materials relating to or in connection with the Contest, these Terms shall prevail.
26. These Terms are written in English and may be translated into Traditional Chinese. In the event of any inconsistency between the English version and a Traditional Chinese version, the English version shall prevail.
27. In case of any disputes, Singapore Airlines' decision shall be final and conclusive.
